## **NOTES**

- Fees are in respect of The Independent Institute of Education's tuition only. Academic material and all other
  expenses, including off-campus internet access and personal IT requirements, are for the student's account.
- Students are required to register per academic year. Fees are quoted per academic year and <u>not</u> for the full
  qualification. The fees included in this schedule are for the 2025 academic year and will be subject to change in
  subsequent years.
- If additional fees are incurred (e.g. for supplementary examinations, sports club fees, academic credit
  applications etc), these fees must be settled within 30 days, regardless of the payment plan selected.
- International students in the contact mode of study at IIE MSA will be subject to an administrative student levy of R5000, payable upon registration and billed annually for every year of study.
- A late registration fee will be levied to returning students only, should we not receive your request for registration
  and minimum payment on or before 03 February 2025. Students registering for a new qualification are exempt
  from this fee. The fees levied are as follows:
  - R2 750 for returning undergraduate contact students.
  - R1 000 for returning postgraduate contact students.
  - R1 000 for returning undergraduate and postgraduate distance students.
- All students are required to consult the academic information section in the Student FAQ Bot to ensure that
  they meet the admission requirements for their selected qualification. Note that some students may be required
  to register and pay for additional modules or Short Learning Programmes (SLPs). SLPs may be added to your
  registration automatically by your campus based on relevant admission requirements. (In certain cases, higher
  certificates indicated provide for an articulation route into bachelor degrees that form part of other schools/
  faculties.)
- Returning students who have failed a module are required to re-register and repeat the module.
- For new students, the non-refundable R2 500 pre-registration fee paid upon acceptance of the offer to study will be deducted from the first payment. Payment of either the full settlement or the 1st instalment for the 10-month option must be paid at the point of registration via PayU when completing your online registration.
- For returning students, payment of either the full settlement or the 1st instalment for the 10-month option must be paid at the point of registration via PayU when completing your online registration.
- Your registration will not be finalised until the first payment has been received.
- If you have selected the 10-month payment option, your first payment must be settled via PayU upon registration
  and thereafter with 9 consecutive monthly payments on the debit order date selected, until the account is settled.
- The monthly payment plan options allow for debit orders on the 1st, 15th or 25th of the month.
- Please note that should the payment plan selected not be adhered to, we reserve the right to adjust this to the 10-month option.
- Where students are the recipients of a loan or bursary (and have the required proof thereof), account payers are liable for any deficit between fees billed and payment received.
- Once you have completed your registration request and payment has been made on the registration portal, your campus will finalise your registration.
- Finalisation of your registration may take up to 5 working days to complete. Once your registration is complete, you will receive the link to Wize Books to order your textbooks and you will receive a copy of your registration contract and a confirmation of registration email.
- Timetables for contact studies will be available one week prior to lectures commencing on the student intranet.
