In keeping with the purpose of professional Bachelors' degrees, this programme will also enable graduates (who may also have obtained admission as an attorney or advocate) to apply a well-rounded theoretical and practical knowledge base and professional entry practice across a broad range of alternative specialisations, careers, enterprise types and industries in both the public and private sectors.

# Admission Requirements

There are prerequisites for this programme that must be met in order to progress through the qualification.

#### National Senior Certificate (NSC):

Bachelor pass with English 60% Maths/HG 50% or Maths lit/SG 60%

#### National Certificate (Vocational) (NC(V)):

Bachelor pass with English 60% Maths/HG 50% or Maths lit/SG 60%

#### Senior Certificate (SC):

Endorsement with English 60% Maths/HG 50% or Maths lit/SG 60%

#### Senior Certificate (Amended) (SC(a)):

Bachelor pass with English 60% Maths/HG 50% or Maths lit/SG 60%

## International:

An USAf Exemption Certificate and meeting the relevant Maths and English requirements.

A cognate Higher Certificate OR cognate 240 credit Diploma OR an Advanced Certificate OR 360 credit Diploma or Degree may satisfy the minimum admission requirements to degree studies.

## Notes:

If discipline not cognate at least 20% of credits must be academic literacy or numeracy related.

Once you have graduated with the Bachelor of Laws and want to be eligible to practice as an attorney or advocate of the High Court in South Africa, you need to be a citizen or permanent resident of South Africa.
